## **Summary Comments**

(on the forms submitted by the Faculty of Architecture)

The University Curriculum Committee has concluded the evaluation of the three Program Forms submitted by the Faculty of Architecture. The programs in consideration are:

- Architecture (hosted by the Department of Architecture): The undergraduate program is going through substantial revision in compliance with the GE policies initiated by the UCC.
- Interior Architecture (hosted by the Department of Interior Architecture): The undergraduate program is going through substantial revision in compliance with the GE policies initiated by the UCC.
- Industrial Design: This is going to be a brand new program of the Faculty of Architecture in compliance with the GE policies initiated by the UCC. The hosting department will be the new Department of Industrial Design itself.

The members responsible for Faculty of Architecture went through these programs and concluded by June 3 (see the attached report) that the program revisions are acceptable subject to some modifications of the relevant Program Revision Forms. The Faculty of Architecture promptly made the modifications and the documents are ready for the approval stage. The subcommittee however made some additional remarks, itemized below:

- Course Title, Transcript Title, Keywords, Catalog Description in Turkish, etc. (Part VIII for both Architecture and Interior Architecture Form and Part V for Industrial Design) should be completed for some external courses such as GEED111 and MATH191.
- The Committee also made the observation that the common courses offered by the
  Other Departments can cause an integrity problem in future (mismatch due to
  contradicting information relevant to a single course). To avoid this problem in future, a
  possible remedy can be to leave these sections (*Part VIII* for Program Revision Forms
  and *Part V* for New Program Proposal Forms) blank.
- Evaluation of present resources, additional facilities, extra staff, etc. are beyond the work
  definition of UCC. The Faculty of Architecture has proposed to increase the academic
  staff size considerably as well as additional facilities. Justification of these requests might
  be necessary. UCC is in no position to make a judgment on this issue.

UCC appreciates the amount of massive work completed by the Faculty of Architecture and anticipates that this initial experience will set an excellent example for the other faculties to follow.
