<p>This course, one of a two-semester non-prerequisite sequence, introduces students to a variety of disciplines in the arts, natural sciences, and social sciences. Like <i>General Survey of Knowledge-I</i>, it discusses critical ideas, concepts and belief systems that are shaping the modern world. This is a team-taught modular course, in which students will learn about a different subject area (e.g. economics, political science, law, philosophy, history, art/archeology, music, communications/literature) approximately every two-three weeks, from a different instructor. This course focuses primarily on economic, political, legal, social and cultural aspects of contemporary life, and ends with a discussion of the impact of the cultural sphere—art, music, literature, and the media—on the individual and society. As current events and interests are constantly changing, the number of modules, module subject areas, some of the content of each module and the reading material recommended by module lecturers may be changed and updated each semester. Lectures and discussion will be accompanied by textual and audiovisual material. Students will be evaluated on the basis of short, knowledge-based exams, and may also be required to submit short essays/a portfolio, discussing one or two of these areas in relation to a particular case study.</p>

**Part II. Rationale - Academic**

General Survey of Knowledge-I and II (GEED 111 and 112) are basic courses required of all first-year students at EMU, and they are reinforced and complemented by a) A portfolio system; b) the first-year Communication in English-I and Communication in English-II (GEED 191 and GEED 192) courses.

GEED 111 and 112 are designed to introduce students to current issues in a broad range of disciplines, and generate their interests in contemporary events and discussions. In the sample framework below, they are structured as a series of two-week modules, the modules being taught by staff members from different disciplines.

These are basic courses intended to broaden students' general knowledge and provide exposure to contemporary topics of discussion in the international media; they are not intended to be detailed or intensive cram courses where students cover every aspect of a subject. A successful module lecturer will generate interest and excitement in a subject area, so that in subsequent semesters students will be enthusiastic about choosing electives offered in that area.

### **Course Content**

The course descriptions for GEED 111 and 112 are not prescriptive, because the current affairs and hot topics in a particular field are constantly changing. The topics listed for each module are only suggestions; the course description is intended only to provide a general framework for the modules, within which *each module lecturer will determine the specific course content for that module, based on his or her expertise in its subject area*. Again, it is important that the modules are taught on a general, issue-based level, rather than on a highly technical or detailed level. Sample general framework:

**Module I. Economics:** Competition, free trade. Inflation, budget deficits. Economic development and income inequality. Foreign exchange, interest rates, stock markets; investments, banks, credit cards. Globalization; privatization. World organizations: World Bank, the G-8, OECD, OPEC, NAFTA..

**Module II. Political Science:** Systems of political/economic organization: fascism, capitalism, socialism, communism, anarchism. Role of individual and state. Concept of democracy. The concept of a "border." Federation and confederation. The European model. Nationalism and globalization. The United Nations. Ethnic conflict and conflict resolution.

**Module III. Law:** International courts. Political context of law. Functions of lawyers. Constitutional law; marriage and family law; women's rights; civil vs. criminal law. Freedom of expression; provocation. Copyright and trademark law. Concept of citizenship. European laws concerning the four freedoms; immigration, citizenship issues. Concept of human rights.

**Module IV. Philosophy:** Branches of philosophy: ontology, epistemology, metaphysics. Religion, secularism; morality, ethics, tolerance. Personal, political, social-cultural, national and legal identities. Shifting borders, globalization, multiculturalism, and identity.

**Module V. History:** The role of history-writing in constructing ideas of memory and destiny, and in creating individual, community, and national identities. Official, popular, and revisionary histories; cultural bias, problems of historical reconstruction, propaganda. Linear, cyclical, religious, and secular histories. Critical thinking opposed to memorization and indoctrination.

**Module VI. Art and Archeology:** Aesthetics. Artistic media. Art and archeology as reflections of society, as forces for change in society. Art and revolution; art as propaganda; official art. Concept of national and world cultural heritage. Museums, curation, and preservation of antiquities.

**Module VII. Music:** The origins and social functions of music and dance. Ritual, entertainment. Classical and popular genres of music; opera. Music and revolution; official music. Music in the service of reform and social protest: folk music, jazz.

**Module VIII. Communications/Literature:** Impact of technology, and textual and visual media on society. Power structures in the media; official discourse; hegemony; propaganda. Private and public media. Freedom of expression and censorship. Educational ideology: school and university systems. Education as an instrument of oppression and liberation.

\*One or more modules may be combined or substituted, depending on logistics, in the first year. The Philosophy module, for example, may be removed from GEED 112 and replace the Comparative Religions module in GEED 111. The course is also designed to be flexible for logistical reasons, so that the actual number of modules and their duration during the semester may vary.

This is a university core course, required of all Freshmen. It is set up in coordination with the Communication in English-II course, GEED 192, and together the courses will provide a broad introduction to current issues in a broad range of disciplines, as well as help develop students' argumentative and technical writing and presentation skills.

**Teaching Policy**

This course will be coordinated by the Chair of General Education or his/her representative and taught by instructors to be proposed by different Faculties. Modules for this course will be developed by these instructors during Summer, 2005, in preparation for the Fall 2005-2006 semester.

### **Staff, Course-load, and logistics**

The General Survey of Knowledge modules may be taught in any order; and for logistical some modules may be substituted by alternative modules in different fields in a given semester.

In the example above, each of the two General Survey of Knowledge courses consists of 7-8 two-week modules. If 7 groups of General Survey of Knowledge-II are opened, this will require the lecturer teaching a module to repeat the same module 7 times (i.e. every two weeks) throughout the semester, each time to a different group.

So, for example the module lecturer will teach the first two weeks in Group I, the next two weeks in Group II, etc. At the end of the semester, the module lecturer will have taught for 14 weeks, so this repeated module will count as a teaching load of one 3-credit course.

Each module lecturer will be responsible for coordinating one Group (see Assessment below).

### **Classroom scheduling**

To simplify the logistics, the 7 groups of GEED 112, for example, will all be block-scheduled at the same time, in 7 large lecture halls (class size will be approximately 100-140). Students in Group I will be assigned to one lecture hall, students in Group II to another, etc., to avoid confusion. The module lecturers will therefore teach 2 weeks in one lecture hall, 2 weeks in another, etc.

### **Coordination with Communication in English-I and Communication in English-II**

Because GEED 111 and GEED 112 are introductory first-year courses, and because each subject area is limited to a two-week module, the reading material *should not be heavy academic articles, but short pieces that the students can handle*. This material will be decided on by the module lecture for each module. It is strongly recommended that these be short Internet newspaper or magazine articles relevant to the module, such as those accessible on Yahoo.com news, discussing current affairs and issues.

For each module, each student will be required to print out or photocopy three articles on a subject/subjects related to issues discussed in that module. At the end of the semester, therefore, the student will have a portfolio of essays. During each module of GEED 111, the student will take a copy of the three relevant articles to the GEED 191 (Communication in English-I course), where these will be discussed further by the English language teachers.

The staff of the Modern Languages Unit of the SFL (School of Foreign Languages) have been working hard for some months to restructure the Communication in English-I and Communication in English-II courses for coordination with GEED 111 and GEED 112. Writing skills modules are being developed for each of the subject areas in the General Survey of Knowledge courses, based on the experience of the staff in the Faculties and Schools to which they provide service. The final course descriptions for Communication in English-I and Communication in English-II are still being finalized. They will include discussion of material from the General Survey of Knowledge courses; essays and technical writing in some of the General Survey of Knowledge subject areas based on the Faculties and Schools to which service is being provided, and presentation skills.

### **Failing and repeating students**

General Survey of Knowledge-I and Communication in English-I are not prerequisites to General Survey of Knowledge-II and Communication in English-II. A student may take General Survey of Knowledge-II and Communication in English-II before taking General Survey of Knowledge-I and Communication in English-I.

—If a student fails both a General Survey of Knowledge course and the parallel English course, that student will be required to repeat both at the same time the following semester.

—If a student passes the General Survey of Knowledge course but fails the parallel English course, that student will only be required to repeat the English course the following semester.

—If a student passes the Communication in English-I course but fails the parallel General Survey of Knowledge course, that student will only be required to repeat the General Survey of Knowledge course the following semester.

### **Grading Policy**

To be determined. As the class sizes will be large (approx 100-140), it is recommended that assessment for GEED 111 and 112 take the form of two multiple-choice exams: a mid-term and a final. As GEED 111 and GEED 112 will be loosely coordinated with Communication in English-I and Communication in English-II (GEED 191 and GEED 192) through a portfolio system, the General Survey of Knowledge and English courses will reinforce and complement each other (see Reading Material/Portfolio System and Coordination with Communication in English-I and Communication in English-II above).

Because the modules will be taught in a different order in each group, a common coordinated exam is not practical. Each module lecturer will therefore be asked to prepare about 50 multiple-choice questions for exam purposes. For the mid-term exam in each Group, the coordinator will select, for example, 10 questions for each module. The mid-term exam will cover, in the Fall semester, approximately 3 modules (30 questions); the final exam will cover 4 modules (40 questions).
